#### **A PUBLIC AND OPEN CALL FOR EXPRESSIONS OF INTEREST**

#### **IS HEREBY ANNOUNCED**

**addressed to all agri-food enterprises interested and meeting the requirements set out in this notice, for participation in the pilot group of the SMART FOOD – Italy Malta project, within the activities envisaged under WP4 – Pilot testing of service delivery.**

## INTRODUCTION

The SMART FOOD project aims to strengthen the competitiveness and sustainability of agri-food enterprises through the use of advanced digital technologies (AI, blockchain, traceability).

WP4 provides for the testing of the services developed within the project through the direct involvement of enterprises expressing interest and meeting the requirements set out in this notice.

The activities envisaged under WP4 are exclusively aimed at the testing, validation and optimisation of the tools developed within the SMART FOOD project and do not constitute individual support measures intended to increase the competitiveness of participating enterprises.

The expression of interest aims to collect applications from MSMEs operating in the agri-food sector with operational headquarters in Sicily or Malta, without establishing a ranking list and without setting a limited number of beneficiaries.

All interested enterprises meeting the admission requirements may participate, subject to the timetable and operational arrangements of the project activities.

The organisation of the activities may take into account territorial and supply-chain representativeness requirements, without prejudice to the open nature of the expression of interest.

Admitted enterprises will participate in the testing of SMART FOOD platform services by testing the platform interfaces, providing data for testing purposes, and supplying useful feedback for the fine-tuning of the project services.

Admitted enterprises will be involved in activities including:

- collective facilitation and operational support activities aimed at testing platform functionalities, using the platform interface and providing development feedback;
- access to the SMART FOOD digital platform for functionality testing;
- testing guidance related to product traceability and valorisation support;
- participation in networking and supply-chain cooperation activities for the tuning, optimisation and validation of the digital services developed by the project;
- testing of experimental data analysis functionalities developed within the project.

Enterprises should preferably belong to one of the following agri-food supply chains:

### Main Supply Chains

- Wheat / bakery products and pasta
- Tomato / processed products
- Olives / olive oil
- Fruit / processed products
- Milk / dairy products
- Meat / processed meat products (cold cuts, meat processing)

### Complementary Supply Chains

- Grapes / wine
- Legumes / processed products
- Fruit and vegetables / fourth-range products
- Dried fruit / processed products
- Aromatic herbs

## REQUIREMENTS FOR PARTICIPATION IN THE EXPRESSION OF INTEREST

Eligible enterprises must:

- be MSMEs operating in the agri-food sector;
- have an operational headquarters in Sicily or Malta;
- operate in production, processing or marketing activities;
- be duly registered with the Chamber of Commerce or equivalent authority;
- not be subject to exclusion conditions provided for by current legislation.

## DURATION OF THE ACTIVITIES

Participation in the pilot group activities will last approximately 6 months, starting from the launch date of the activities, tentatively scheduled for the period June 2026 – November 2026, subject to any extensions related to project implementation.

## REPORTING

Admitted enterprises undertake to cooperate in the monitoring and evaluation activities envisaged by the SMART FOOD project.

In particular, enterprises undertake to:

- provide, upon request by the beneficiary, information and data useful for monitoring the progress of activities and testing results;
- participate in questionnaires, survey forms and feedback tools, including digital formats;
- contribute to the collection of elements useful for the qualitative and quantitative evaluation of the tested services;
- take part, where required, in periodic review activities (meetings, interviews, follow-up sessions);
- authorise the use, in aggregated and anonymous form, of the collected information for reporting, communication and dissemination of project results.

Reporting and monitoring activities do not entail administrative or accounting burdens for enterprises, but are limited to providing information and data related to participation in the project activities.

#### METHODS AND DEADLINES FOR SUBMISSION OF THE EXPRESSION OF INTEREST. GROUNDS FOR INADMISSIBILITY

For admissibility purposes, the application for expression of interest attached to this notice (ANNEX A) must be signed and include personal details and all information necessary to clearly and unequivocally demonstrate the fulfilment of all admission requirements.

The following may be attached to the expression of interest:

- Any informative material

The final deadline for receipt of the expression of interest application is 11 May 2026 at 12:00 noon. In the case of postal delivery, the postmark date shall not constitute proof of timely submission.

Statements made and signed in the expression of interest application shall be considered self-certifications; therefore, supporting documentation need not be attached, although it may be requested if deemed appropriate by the contracting authority.

Applications shall be deemed inadmissible in the following cases:

- incomplete or unsigned application;
- failure to sign the application;
- submission after the deadline;
- absence of admission requirements.

#### PROCEDURE FOR ADMISSION OF EXPRESSIONS OF INTEREST

Applications received will be verified by CNA Servizi Enna in order to ascertain compliance with the admission requirements set out in this notice. This procedure does not constitute a comparative procedure, does not provide for the attribution of scores, and does not establish a ranking list. All interested parties meeting the required criteria will be admitted to participate in the project activities according to the arrangements and timetable defined within the SMART FOOD project.

CNA Servizi Enna may request additional documentation or clarifications where necessary to verify the declared requirements. Failure to provide the requested supplementary information within the specified timeframe may result in inadmissibility of the application.

#### METHODS OF PARTICIPATION IN THE ACTIVITIES

The activities will be organised consistently with the objectives of WP4 and may include coaching sessions, access to and testing of the SMART FOOD digital platform, feedback collection, networking opportunities and supply-chain cooperation initiatives.

Participation by admitted enterprises shall not give rise to contractual relationships or service assignments, nor shall it entitle participants to any remuneration. The expression of interest is solely intended to identify parties interested in participating in the testing of services developed within the project.

In order to ensure adequate representation of the supply chains and territories involved, the organisation of activities may, where possible, enhance the participation of enterprises belonging to priority supply chains and operators active in the various stages of the supply chain, without prejudice to the open nature of the procedure and the admission of all subjects meeting the requirements.
